Students may use this form to request a non-electronic Student ID Card, issuance of a BRIVO© Mobile Pass account, or reactivation of a BRIVO© Mobile Pass account.

This form will be accepted via email <u>only</u>. Payment, if required, may only be made via Student Gateway or directly with Student Accounts. No form of physical payment is accepted on campus. **All students living within 30 miles of campus are required to pick-up their ID Card in-person. Your ID Card will be ready for pick up after approximately 7-10 business days.** In order to verify your identity, Pacific Oaks requires that you present another form of photo ID before we can release your ID Card. ID Cards will be mailed to the address provided on this form to students living more than 30 miles from the campus.
