# Pacific Oaks College Loteria - Official Rules 

## NO PURCHASE NECESSARY TO ENTER OR WIN. VOID WHERE PROHIBITED BY LAW.

1. SPONSOR: The Sponsor of the Pacific Oaks Loteria contest ("Contest") is the Pacific Oaks Education Corporation, located in Pasadena, California.
2. HOW TO ENTER: The contest is open to individuals who are current Pacific Oaks College students. PO students will receive their 2023 Calendar with the playing card inserted via mail (U.S mail). To submit an entry, a student must send an email to SSC@pacificoaks.edu containing "LOTERIA!" in the subject line; the body of the email must contain the entrant's full name, phone number, and an image of the front and back of the entrant's playing card. Entrant's name and phone number will be used for prize notification purposes only.
3. All entries become the sole and exclusive property of Sponsor and receipt of entries may not be acknowledged or returned. Sponsor is not responsible for lost, late, illegible, stolen, mutilated, incomplete, invalid, unintelligible, misdirected, postage-due, technically corrupted, or garbled entries or mail, which will be disqualified, or for problems of any kind whether mechanical, human, or electronic. Only fully completed entry forms are eligible. Proof of submission will not be deemed to be proof of receipt by Sponsor.

5. ELIGIBILITY: Open to current Pacific Oaks College students, 18 years or older. Void where prohibited or restricted by law. All federal, state, and local laws and regulations apply. One entry per person.
6. SELECTION OF WINNERS AND PRIZE: Winners will be selected based on order of receipt of qualifying completed playing card. The first five qualifying submissions containing four qualifying diagonal, horizontal, or vertical images will win a $\$ 75.00$ Amazon.com Gift Card. The first five qualifying submissions containing a fully completed card will win a $\$ 100.00$ Amazon.com Gift Card. By entering the Contest, entrants fully and unconditionally agree to be bound by these rules and the decisions of the Associate Director which will be final and binding in all matters relating to the Contest.
7. WINNER NOTIFICATION: The winners will be notified by email. Prize will be made available for pick-up on campus in Pasadena, California. If the winner(s) live more than 50 miles from the Pasadena Campus, the prize will be mailed using UPS courier services or United States Postal Service. If any prize or prize notification is returned as undeliverable, if any winner rejects his/her prize, or in the event of noncompliance with these Contest rules and requirements, such prize will be forfeited, and an alternate winner will be selected based on order of submission of qualifying entry. Upon prize forfeiture, no compensation will be given.
8. CONDITIONS: Participant's entry into the Contest constitutes agreement to these

Official Rules. The Rules and any disputes hereunder shall be governed by and subject to the laws of the State of California and the United States. All federal, state, and local taxes are the sole responsibility of the winner.
